

Terms of Reference:

Community Mobilizer for Project VICE (Violence Intervention Through Community Engagement)

Objective: Gang Alternative, Inc. is seeking a Community Mobilizer Consultant who will play a pivotal role in identifying at-risk youth and organizing community engagement events to address gang and youth gun violence. The Community Mobilizer will identify at-risk youth exposed to gun violence in Carol City, North Miami Beach, North Miami, Little Haiti, Little West River, Liberty/Model City, Overtown, Allapatha, Little Havana. They will coordinate with GA to provide necessary prevention education and intervention services based on needs assessment, identify potential community partners, and organize monthly community engagement events.

Responsibilities:

- Identify at-risk youth who are or have been exposed to gang and gun violence in the target communities.
- Assess the needs of each youth and refer them to appropriate services, such as substance abuse treatment, mental health counseling, educational support, job training, and family services.
- Plan and coordinate monthly community events, such as fairs and block parties, to address gang and youth gun violence, ensuring inclusion of prevention and intervention education.
- Identify and engage potential community partners to participate in these GA-sponsored events.
- Collaborate with GA, community leaders, law enforcement, and other stakeholders to ensure successful events.

Deliverables:

- Organize and lead weekly community engagement events per month to raise awareness about gang and youth gun violence and promote prevention and intervention efforts. Events should be well-coordinated, involve various community stakeholders and partners, and include prevention education and intervention support protocols.
- Provide monthly reports on community outreach activities, including the number of youth identified and events organized.
- Identify and engage potential community partners, documenting their involvement and contributions to community events.

Evaluation Metrics:

- Number of at-risk youth identified and assessed.
- Attendance and impact of monthly community engagement events.
- Number and quality of partnerships developed with community organizations.
- Feedback from youth, community members, and stakeholders on the effectiveness of outreach and events.

 - iii. Summary of relevant experience, emphasizing past projects or roles demonstrating expertise in areas pertinent to the consultancy.
 - iv. Outline of the proposed approach to addressing the objectives and deliverables as indicated in consultancy scope of work. This should encompass methodologies, timelines, and any innovative strategies intended for implementation.
 - v. Applicants should provide a list of references from previous clients or employers who can vouch for their skills and capabilities, to be contacted if necessary.
- Shortlisted candidates may be invited to participate in interviews or presentations to further assess their suitability for the consultancy.
- Successful candidates will receive further instructions regarding the next steps in the consultancy process.
